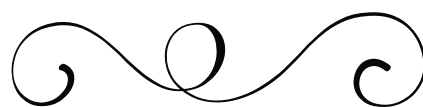

Tryout Routine Information and Price Requirements:

- All team members are guaranteed two team routines. Members are eligible to tryout for 2 extra routines.
*Tryout routines are optional. **TRYOUTS - August 7th -5:30**
- \$45.00/monthly extra tuition per tryout routine (due before the 10th of each month)
- \$65.00 costume fee per tryout routine (due Sept 1st and Sept 15th)

DC Policies and Procedures

- DC encourages parent involvement by sending information out regularly by Remind 101 texts, Facebook, Twitter, Instagram, our website, and occasional handouts. It is expected of the parent to keep up with your dancer's schedule, events, and dates.
- DC does not offer makeup classes due to inclement weather, illness, or school functions, etc.
- Please label all belongings. The Lost & Found box is located at the receptionist desk. All lost items will be donated at the end of each month. The studio will not be held responsible for lost or stolen items. Keep all valuables at home to avoid the risk of lost or stolen items.

Policy for payments:

- Methods of payments can be cash, check, credit/debit card. Auto draft & Credit/Debit card transactions will acquire a 3% processing fee for each transaction.
- Monthly fees are to be paid in full. If your account has any outstanding balances past the 15th of the month your dancer will not be able to practice, perform or compete in any DC engagements.
- There will be no refunds issued. Any refunds will be situationally determined. If a refund is granted, there will be a \$10.00 processing fee. DC requires a 30 day cancellation notice for all students.
- You will be notified if your account is overdue. All accounts not paid by the 10th of each month will acquire a \$15.00 late fee.
- There will be a \$25.00 processing fee for all returned checks or declined credit/debit cards. If any of the account holder's information were to change within our auto draft system, it is your responsibility to notify DC. If you do not notify us five days before the draft day, you will still be responsible for the \$25.00 processing fee.
- Our Auto draft policy requires a 30-day notice of cancellation. There will be no refunds if a request is not submitted.

Arrival & Departure Policy:

- Please do not drop your dancer off more than 10 minutes before their class time. Please be ON TIME when picking your dancer up after his/her class time. It is not Dance Connections responsibility to provide child care while in the lobby.

Lobby Expectations:

- Please be considerate of other customers, as well as our students, while in the lobby of the studio. Please be courteous as dancers & instructors can hear loud noises from the lobby. Siblings of students need to be supervised AT ALL TIMES within the walls of DC.
- No running or yelling. No playing with water fountain, toiletry items, vending machine, or DC merchandise.
- All dancer's siblings under the age of 6 need to be accompanied to the restroom by a parent.

Accident Policy Agreement

I understand that I have enrolled the above child in a program of physical activity for Dance Connections, DBA & DC Dance, LLC. I realize that participants are under no pressure to physically exert themselves beyond his/her capacity and it is the parents and/or participants responsibility to use personal judgment concerning the degree of their participation in all activities. I, the child`s parent and/or legal guardian represent that I understand the nature of the activities and that the above named child is qualified, in good health, and in proper physical condition to participate in such activities and that I am authorized to sign this Release and Waiver. I fully understand that the activities involve risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by the child`s own actions, inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the “releases” named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my child`s participation in the activities. I hereby release, discharge, and covenant not to sue Dance Connections, DBA and DC Dance, LLC, or their respective employees, and other participants (the “Releases”) from all liability, claims, demands, losses, or damages, on the child`s account caused or alleged to be caused in whole or in part by the negligence or the Releases or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk of the child or anyone on the child`s behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the Releases from any loss, liability, damage, or cost, which any may incur as the result of such claim, including without limitation litigation expenses and attorneys` fees.
